### REQUIREMENTS FOR ADMISSION

- National Senior Certificate or an equivalent educational qualification at NQF level 4, with an endorsement for entry into higher education.
- Compulsory subjects passed are English, Mathematics/Maths Literacy and Life Science/Biology
- An applicant without Life Sciences/Biology in matric, or whose mark is below the minimum achievement level of NSC 4 (50%), can still be eligible through the recognition of prior learning. (e.g. Fundamental programme: Basics of Anatomy and Physiology)
- This is our pre-selection criteria programme.
- Students who enrol in the programme must pass with an aggregate of 70%.
- Successful completion may help the applicant gain access to the higher certificate, provided all requirements are met.
- Future Nurses Nursing School will accommodate successful students based on merit, capacity, and a first-come, first-served basis.
- All non-South African applicants are required to verify their high school certificate with SAQA
- Proof of payment for application handling (R1000)
- If the application document is not complete, the application will not be processed
- Auxiliary Nursing fee for 2027 and 2028: R80 000 EXCLUDING study material and uniform
